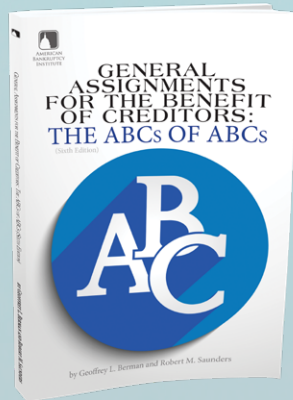

Since the publication of the fifth edition, there have been significant developments, especially in Delaware and Florida, that provide new direction in those states and offer guidance for other jurisdictions, which may clarify the future path of ABCs. Additionally, the Uniform Law Commission is reviewing a final draft Uniform Act that reflects a growing consensus on ABCs, while recognizing the considerably different approaches of the states. This update provides a concise overview of the current status and potential foreseeable changes in ABCs.

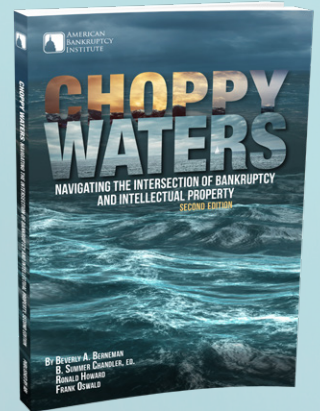

The *Purdue Papers* Amicus Briefs and Commentaries Related to *Purdue Pharma L.P., et al.* (digital only)

On June 27, 2024, the U.S. Supreme Court rendered its 5-4 decision on a petition by the Trustee regarding the case of *Purdue Pharma L.P.* The Court reversed the Second Circuit's *Purdue* decision and declined an invitation to anoint chapter 11 as the remedy for deficiencies in the state and federal tort systems. Even before the decision, the case had already generated a mountain of commentary in the form of *amicus* briefs, petitions and other related background material. Guided by editor David R. Kuney (who represented one group of *amicus* filers), ABI has gathered together all of this material in a fully searchable form — more than 3,300 pages worth! This collection includes the final Supreme Court decision, as well as a commentary by ABI Editor-at-Large Bill Rochelle, who writes *Rochelle's Daily Wire*, and a transcript from a July 2, 2024, webinar that discussed the implications of the final decision. This ebook is an invaluable resource for anyone working in the area of third-party releases.

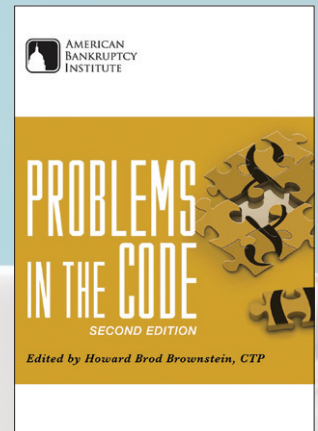

The articles collected in this new edition encompass the remarkable diversity of topics that have been the subject of those pieces, and although Congress has acted on a few of the Commission's recommendations, it is clear from the material featured in this second edition that there is still work to be done. This digital volume is a useful guide to some of the more problematic corners of the bankruptcy field.
