

ABI Preference Handbook Third Edition



Chapter 12 from A to Z A Guide to Bankruptcies of Family Farmers and Family Fishermen


This guide offers a comprehensive look at an important but often overlooked chapter of the Bankruptcy Code. While chapter 12 filings showed a small but steady increase from 2015 to 2020, there are some signs that higher commodity prices and government support programs are helping stave off financial ruin for distressed farmers, with filings declining about 24 percent so far in 2021. But chapter 12 sometimes remains the only option for struggling farm operations, particularly in the drought-stricken West or in the flood-ravaged Mississippi Basin. Included in this timely publication is a helpful section on tax provisions and issues related to the disposition of farm property.

Bankruptcy in Practice Sixth Edition



General Assignments for the Benefit of Creditors The ABCs of ABCs, Fifth Edition


Assignments for the benefit of creditors — or “ABCs” — have evolved from small cases with claims of under \$1 million to the dot-com implosion and now into a much more commonplace tool used for the expedited sales of assets, similar to § 363 sales under the Bankruptcy Code. State legislatures across the country are reviewing and in many instances revising their laws governing ABCs and receiverships, and there has been an increase in court decisions about ABCs. This Fifth Edition addresses these changes and issues for insolvency practitioners to be knowledgeable about when considering the use of the ABC alternative.



The Zone of (In)solvency Fiduciary Duties and Standards of Review for Corporations and Limited Liability Companies



Remote Court Hearings Present Practice and Future Prospects (digital only)




Thorny Issues in Consumer Bankruptcy Cases, Second Edition
